#### VDI scale for reporting an odour complaint.

Feedback or Odour complaints can be reported to Redvale Landfill through three different methods,


- 1. Email redvalecomplaints@wastemanagement.co.nz
- 2. Phone call 09 427 0600 or 021 190 2018
- 3. Text message 021 190 2018

To work with us, please provide constructive feedback only, which includes the following information,

- 1. Time and location of the odour
- 2. Type of the odour
- 3. Character and intensity of the odour
- 4. Frequency of the odour how often it occurs, duration of the odour and time of exposure.

VDI scale example below on how to classify odour intensity.

## Odour Intensity



Odour Intensity: The perceived strength of an odour above its threshold. It is determined by an odour panel and is described in categories that progress from "Not perceptible"; "Very Weak"; "Weak"; "Distinct", "Strong", "Very Strong", to "Extremely Strong".

The best way of assessing odour is via the human nose. But everyone reacts to odours differently. One person may object strongly to an odour while another is not bothered by it. The only objective method to assess odours is a calibrated nose that has completed Olfactometric measurement.

#### Dear readers,

This is the second newsletter for this year and a third of the year has passed. I am writing this newsletter the day after May Day and reflecting on the state of the world and our position in it. The Russo-Ukrainian war lingers on and the Israeli conflict has expanded to include Iran and neither conflict seems to have an easy solution in sight.

Closer to home, there has also been some sabre rattling as well as rumblings of another kind ... a large magnitude earthquake affected Taiwan recently (with surprisingly low fatalities) and currently, volcanic activity in Indonesia has necessitated closure of airports and evacuation of populations close to the activity.

On the home front, there are signals that our economy is correcting itself, with inflation coming down and talk that the OCR may be reduced at the end of this year or early next year. Also, very close to home, Auckland Council have released an update on the Spatial Land Use Strategy for the Dairy Flat and Silverdale Future Urban Zones.

For those who haven't seen this 18 April announcement, it is summarised as follows:
The key change is that the metropolitan/town centre is now located solely on the Rapid
Transit Corridor (RTC) alignment and does not extend to the Green Road Park. In this
location the centre avoids flood plains which was an issue raised in the feedback on the
draft. The centre is centrally located in the Dairy Flat Future Urban Zone so will be
accessible to a large number of future residents. It should be noted that the extent of the
centre and the associated higher density residential area is conceptual and the
boundaries are not rigid. The detailed location will be determined at the future structure
planning stage which may be 20 years away. There are also changes in the Pine Valley
area with two stations now proposed there. A range of other changes have also been
made to the Strategy in response to the feedback.

Our next Community Liaison Committee meeting is scheduled for 6.30pm on 13 May, a reminder to all readers that these meetings are open to the public. If intending to attend, please do let WM New Zealand know so that additional seating can be arranged.

In closing, I again appeal to all readers to please support the advertisers promoting their services in this newsletter.

Locals supporting locals is always a good thing!

#### Rodney Local Board member.

I hope you have all had a great summer. Over the last couple of months, Auckland Council have been busy finalising the ten-year budget, which is not looking pretty, especially with the proposed rate rises.

To balance the budget, there will be several tough decisions to be made, including the fate of the North Harbour stadium. Many locals were involved in the fundraising for the stadium, and it was once a thriving venue for concerts and major sporting events. However, since Auckland Council took over the stadium's management in 2014, patronage and the facility itself has deteriorated significantly.

As a Local Board, we are advocating for the stadium to be retained, funding spent on repairs, and the operating management to be changed, but the ultimate decision lies with the Mayor and the twenty other Councillors.

On a more positive note, the draft 10-year budget does include 124 million for the unsealed road improvement program. This includes supporting innovative and low-cost techniques for improving/sealing our unsealed road network. As a Local Board, we are requesting that this funding be allocated evenly over the 10-year period. I will keep you updated on the progress.

Below is a quick update on what else has been happening in Dairy Flat.

#### **Storm Recovery**

It is hard to believe that we were ravaged by floods in Dairy Flat over a year ago. Many residents are still in limbo as they await categorisation from Auckland Council's flood recovery team, having chosen to opt into the Council's voluntary buyout program. This is a very emotional and difficult time for them and their neighbours. Below is a quick summary of the Council's voluntary buyout scheme.

'Auckland Council is offering significant financial support for owners of homes where there is an intolerable risk to life from future severe weather events. This is a risk-based program, and the funding available to homeowners depends on the Council's assessment of their property risk. The main risk categories are detailed below:

- Where there is an intolerable risk to life from future severe weather events, and nothing can be done to mitigate the risks feasibly, then Auckland council are offering a voluntary buy-out and these homes are classified as a Category 3 risk.
- Grant funding, available to do work on a property to reduce the risk to an
  acceptable level, such as raising homes. These homes are classified as
  Category 2P.
- Homes that are at an acceptable level of risk to life from future severe storm events are considered Category 1 and no direct financial assistance is available.

Property owners can opt-in to the voluntary categorisation programme via the online registration form at <a href="mailto:property.flooded.co.nz">property.flooded.co.nz</a>, or email <a href="mailto:propertycategory@aucklandcouncil.govt.nz">propertycategory@aucklandcouncil.govt.nz</a>

To date, six properties in Dairy Flat have been assessed as category 3, and the Council is in negotiations to purchase the properties.

Once the properties have been purchased, the Council will begin removing any dwellings from the sites. What will happen to the land use long-term is still to be determined. These decisions will be much more straightforward in urban areas as the sites could be used for parkland. For rural areas we need to ensure that they do not become covered in weeds and other pests.

Many residents across Auckland in areas that have been identified as high risk have chosen not to opt into this process. Auckland Council is very concerned if there are another weather event people are living in very high-risk homes with an intolerable risk to life. Unfortunately, going forward managed retreat will be driven by the insurance industry. The cut-off date for opting into the Council buy out process has now been set to the 30th of September 2024.

#### Planning for the Urbanisation of Dairy Flat

The spatial land use strategy for Dairy Flat has now been formally adopted by the Governing body. This is a high-level plan and details where the future town centres will be in Dairy Flat when it is urbanised. As a Local Board, we were very concerned that the proposed main town centre and rapid transport station are planned be located near Grace Hills, with the surrounding high-density housing planned next to major flood plains however this was not deemed a concern by the majority at the Governing body level.

In the strategy, another local centre and rapid transit station are proposed immediately to the west of Pine Valley Road, which adjoins the proposed industrial area. This station will include a park-and-ride with 500 vehicle spaces. It is designed to serve the large rural areas to the west along Pine Valley Road and Kahikatea Flat Road. An additional indicative local centre is also shown, with a possible second station located to the southwest, which will serve the likely future Pine Valley residential area in the south and west.

One very frustrating thing is that this strategy is so high-level, and detailed analysis will not happen for decades when the area is structure planned and this includes the detailed assessment of the integrated storm water management.

Dairy Flat is now not planned to be developed until 2050, so many may not be around to see the urbanisation. However, developers can still lodge out-of-sequence plan changes, and I understand that there are three in the pipeline, but these plan changes have not been formally lodged. However, these are closer to Milldale and the proposed industrial area of Dairy Flat.

#### **Hearing for the Notice of Requirements**

As part of the planning for the urbanisation of Dairy Flat and route protection, the Supporting Growth Alliance (Auckland Transport/Waka Kotahi and Council) has lodged 13 Notice of Requirements (NoR) with Auckland Council. Feedback has now closed, and 430 submissions were received on the NoRs. The hearing will start on Monday, 17 June, and will be held at the North Harbour Stadium. You will need to complete a registration form if you will be speaking. If you have submitted on the NoRs. I always think it is more powerful for independent commissioners to hear

feedback directly from residents rather than just reading a submission. I will be providing feedback on behalf of the Rodney Local Board.

**NoR 4:** State Highway 1 Improvements – Albany to Ōrewa and Alterations to Existing Designations 6751, 6760, 6759, 6761

NoR 5: New State Highway 1 Crossing at Dairy Stream

NoR 6: New Connection between Milldale and Grand Drive, Orewa

NoR 7: Upgrade to Pine Valley Road

NoR 8: Upgrade to Dairy Flat Highway between Silverdale and Dairy Flat

**NoR 9:** Upgrade to Dairy Flat Highway between Dairy Flat and Albany

NoR 10: Upgrade to Wainui Road

NoR 11: New Connection between Dairy Flat Highway and Wilks Road

NoR 12: Upgrade and Extension to Bawden Road

NoR13: Upgrade to East Coast Road between Silverdale and Redvale
